

PARTICIPANT AGREEMENT, RELEASE AND ASSUMPTION OF RISK

In consideration of the services of Pineridge Grouse Camp, LLC, their agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as "PGC, LLC"), I hereby agree to release, indemnify, and discharge PGC, LLC, on behalf of myself, my spouse, my children, my parents, my heirs, assigns, personal representative and estate as follows:

1. I acknowledge that hunting at PGC, LLC and that hunting itself entails known and unanticipated risks that could result in physical or emotional injury, paralysis, death, or damage to me, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity.

The risks include, among other things: the use and carrying of firearms; contact with wild animals, hiking and exposure to the elements: slips and falls; latent or apparent defects or conditions in equipment use or operation, by myself or others, of equipment and dogs, whether or not supplied by PGC, LLC; acts of other participants in this activity, employees and agents of the club, or any other person; weather conditions; contact with plants or animals, whether trained or wild; my own physical condition, or my own acts or omissions; conditions of roads trails, waterways or terrain, and accidents connected with their use; first-aid, emergency treatment or other services rendered; and consumption of food or drink.

Furthermore, PGC, LLC employees have difficult jobs to perform. They seek safety, but they are not infallible. They might be unaware of a participant's fitness or abilities. They might misjudge the weather or other environmental conditions. They may give incomplete warnings or instructions, and the equipment being used might malfunction.

2. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.
3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless PGC, LLC from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of PGC, LLC's equipment or facilities, including any such claims which allege negligent acts or omissions of PGC, LLC.
4. Should PGC, LLC or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.
5. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I am willing to assume the risk of any medical or physical condition I may have.
6. In the event that I file a lawsuit against PGC, LLC, I agree to do so solely in the state of Minnesota, and I further agree that the substantive law of Minnesota shall apply in that action without regard to the conflict of law rules of that state. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining document shall remain in full force and effect

By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against PGC, LLC on the basis of any claim from which I have released them herein.

I have had sufficient opportunity to read this entire document. I have read and understood it, and I agree to be bound by its terms.
